Dr. Peter Jepson-Young's brave choice to document his AIDS journey through the 'Dr. Peter Diaries' established a legacy that outlived his tragically brief life. His groundbreaking television series humanized the AIDS epidemic for Canadians nationwide, at a time when stigma and fear prevailed. Dr. Peter's vision of compassionate, dignified care for those living with HIV/AIDS laid the foundation for what would become the Dr. Peter Centre.

Shirley, standing steadfastly by her son's side, channeled her grief into action after his passing in 1992. She became a major driving force behind the creation of the Dr. Peter Centre, ensuring that her son's vision of compassionate care would endure. 

Who are the 2% we
stand for?



Imagine your name is Jo.

It's 7 o'clock in the morning, and you've woken up in the same clothes you went to sleep in. You're cold. You're shivering, and you're wet.

You are hungry but have nothing to eat. The closest food bank is on the other side of town, and it doesn't open for another three hours.

You need your meds, but the place that is holding them for you is 13 long blocks away. **Just around the corner, however, the neighbourhood dealer is always open for business.**


The clinic you count on for therapy is overbooked, so your chronic pain goes untreated.

You have no phone or address, so there is no way for friends, family, or job prospects to reach you, or for you to reach out to.

Without transportation, **your world is limited to the places you can walk to.**

That night, like every night, you will need a place to sleep. If you are willing to line up on the street for several hours, you might be lucky enough to find a bed in a crowded shelter, but **only if you are willing to leave your pet or partner behind.**

Wherever you lay your head, sleep will not come easy.

that represents approximately 750,000 Canadians facing complex, overlapping challenges that have sidelined them from society. These individuals, embodied by the archetype 'Jo,' navigate a harsh reality of homelessness, substance use, mental health issues, and often, chronic illnesses.

'Jo' could be a 19-year-old picked up for drug possession, a 30-year-old sleeping on a park bench, an Indigenous woman committed to involuntary care or a refugee recently diagnosed with HIV. They might frequent emergency rooms, miss health appointments, and have a history of overdose. Banned from shelters due to behavioral challenges, 'Jo' may engage in public drug use and experience family estrangement.

These individuals are not hard to reach, but due to their complex needs, they are hard to treat. They often fall through the cracks of our fragmented care system. This 2% is not just a percentage of our population; they are people with stories and unmet needs that require compassionate, integrated support.

By focusing on the 2%, we address a moral imperative and work towards relieving pressure on our overburdened services. **Our goal is to see the whole person,** offering human-centered care that recognizes their complexity and dignity. Through this approach, we aim to create lasting change for all Canadians.

“My journey has been a rollercoaster of highs and lows, starting with the excitement of opening my own restaurant in downtown Vancouver, only to have everything taken away unexpectedly. By entrusting my landlord and realtor with my complete faith, I was met with fraudulent behavior that led to the loss of my parents' inheritance, my life savings, and my newly renovated home. Despite enduring challenges, I remained steadfast in my integrity and determination, refusing to succumb to bankruptcy. I persevered through adversity but found myself living in a tent in city parks for eight months.

It was during this difficult time that I was introduced to the Dr. Peter Centre by my case manager from the community, and I was immediately blown away by the support and care I received. The therapists have helped me rediscover my passion for music and now art, and the community at the Centre has provided me with a sense of belonging and purpose. I am honoured to have had my work displayed in the Dr. Peter Centre community art show and to have connected with Dr. Peter's family, who have been touched by my story. The staff and programs at the Centre have played a crucial role in my healing and transformation, and I am forever grateful for their guidance and support.”





Our Vision for National Change

SEVEN-YEAR SNAPSHOT

Since 2017, the Dr. Peter Centre has been at the forefront of addressing Canada's most complex health and social challenges. Our impact has extended far beyond our local roots:

- Implemented 15 national PHAC and SUAP contracts, totaling \$20 million
- Established a harm reduction network of 440 organizations nationwide
- Conducted 342 Community of Practice engagements
- Facilitated 72 "Incubators" on critical topics including Supervised Consumption Sites and safe supply

AN URGENT NEED FOR ACTION

The crisis is worsening:

- Overdoses, encampments, and visible homelessness are on the rise
- Complex health issues overwhelm emergency services
- Public safety concerns are escalating
- Political rhetoric overshadows effective solutions

OUR SOLUTION: COMPREHENSIVE NATIONAL INITIATIVES

1. Humanity Heals

A transformative five-year initiative focusing on Canada's most vulnerable 2%.

Key Strategies:

- Drive Human-Centered Care Models
- Unify Frontline Organizations: Break down silos, develop common language and leadership
- Co-Create Funding Efficiencies: Establish sustainable funding structures with corporate and philanthropic engagement

2. National Support System for Frontline Organizations

A \$5.8 million SUAP-funded project to develop a national support system for frontline organizations aiding people who use drugs. This project complements Humanity Heals by strengthening our network of organizations across Canada to deliver effective, compassionate care.

Campus of Care



Our **Campus of Care** isn't just a place; it's a promise. It's a commitment to the 2% of our population sidelined by society that they can continue to access care that values them as members of society. Through our holistic, trauma-informed care, we prove that turning chaos into community isn't just possible—it's essential.

This year:

- **Cultural and Wellness Initiatives**
 - Totem carved at the Centre and raised in the front lobby
 - “Two-Eyed Seeing” implemented in Residence and Day Health; a concept of understanding the world through both Indigenous and Western perspectives
 - Welcomed over 80 asylum seekers from Latin America
 - Launched a podcast for transgender care
 - Reinstated volunteer therapies: massage therapy, Reiki, and haircuts
- **Staff Development**
 - Improved crisis intervention, conflict resolution, and safety intervention training
 - Enhanced database integration (reviewed and improved the intake process and participant list, implemented Pharmanet and CareConnect for nursing team)
- **Community Engagement and Partnerships**
 - Enhanced relationships with Ministry of Social Services and Community Policing
 - Held our first external art exposition with over 15 participants, 100+ pieces, and successful sales

Frontline Solutions



Frontline Solutions leverages the Centre's extensive experience and innovative approaches to align with other frontline organizations across the country working with the 2%.

This year:

- **Knowledge Dissemination**
 - Distributed and expanded our Knowledge Bundles, incorporating community feedback from Indigenous leaders and those with lived and living experience
- **Community Engagement and Collaboration**
 - Conducted multiple Community of Practice (CoP) calls with a total of 215 participants
 - Developed partnerships with key new frontline partners
 - Hosted 22 experiential tours for international organizations
- **Capacity Building**
 - Completed year-long, capacity-building training for healthcare professionals and community organizations
- **Research and Publication**
 - Published academic research about our iOAT program in the Addiction Science & Clinical Practice journal
 - Launched the Women and Gender Expansive Persons (WGEP) report




