
#### **Position Summary**

The role of the Nurse Practitioner in the Residence program is the provision of primary, secondary, and tertiary preventative care with the overall goal of improving the person's health.

Reporting to the Senior Director of Clinical Programs, as a member of a multidisciplinary team, using an interdisciplinary approach to care, the Nurse Practitioner is responsible for the comprehensive assessment of participants utilizing the nursing services.

The Nurse Practitioner initiates treatment including health care management, therapeutic interventions and prescribes medications in accordance with the statutory and regulatory standards, limits and conditions, and employer's policies and procedures. The Nurse Practitioner provides professional guidance to nursing care staff and collaborates with the participants' primary care providers.

The Nurse Practitioner is a practice leader assisting in the developing, implementation and evaluation of evidence-based activities that influence the health service and practices.


# **Key Responsibilities**

- Diagnose and treat previously undiagnosed participants for undifferentiated disease and conditions within the Nurse Practitioners' scope of practice;
- In collaboration with primary care physician, monitors ongoing care, orders appropriate screening diagnostic investigations; interprets reports of investigations and analyzes information to monitor progress and plan treatment;
- Initiate treatment including health care management, therapeutic interventions and prescribe medications in accordance with the statutory and regulatory standards, limits, conditions, and employer's policies and procedures;
- Provide professional mentorship to other health providers and practices autonomously and interdependently within the context of an interdisciplinary health care team;
- Participate in the development of policies, procedures and protocols relevant to the nursing, interdisciplinary care, and health system practices;
- Participate in quality improvement and program evaluation including self and peer review processes;
- Responsible for own professional development and maintaining competence in the position and maintaining a collaborative practice with the program-specific consulting physicians; and
- Perform other related duties as assigned or required.

## **Education, Qualifications and Experience**

The preferred education, qualifications and experience of the Nurse Practitioner are:

- Current registration as a Nurse Practitioner with the BC College of Nurses and Midwives;
- Recent and relevant primary care experience treating adults;
- Preferred knowledge and experience in the following areas: HIV, Hepatitis C and substance use disorder and end of life care;
- Ability to communicate with clients about health findings, diagnosis, treatment, and self-care;
- Ability to collaborate, consult, and refer clients to physicians and other healthcare providers;
